As you are aware, the Department of School Education & Literacy, Ministry of Education, Government of India, launched the **School Challenge: Towards a Tobacco-Free Generation** on the MyGov platform from **11th June 2025 to 31st October 2025**, with the objective of promoting awareness among students through creative and participatory activities.

- Under this initiative, schools were encouraged to organise four activities Rally, Nukkad Natak (street play), Poster Making, and Slogan/Poem Writing and submit the entries on the MyGov portal for participating in the school challenge. These activities were conducted widely, with enthusiastic participation from students and teachers across all States/UTs. The first stage of the Challenge, involving the conduct of activities by schools and the uploading of submissions, has been successfully completed. The Department acknowledges and appreciates the active support extended by all States/UTs in this endeavour.
- Since the Challenge has now progressed to the evaluation stage. Therefore, the evaluation of the entries by the District, State and the National Jury shall be held in the phased manner. Thereafter, the winner shall be declared and felicitated at the national level. The State/UT wise excel sheet comprising of the entries received from the schools on the MyGov portal along with the evaluation sheet is attached. The suggestive guidelines for the evaluation of the entries at the district and the state level is also enclosed.
- The States/UTs shall bifurcate the entries district wise and share with the respective district for evaluation. The deadline for district evaluation is 31<sup>st</sup> December 2025. The Department will also conduct orientation sessions for States/UTs including the district nodal officers for further explanation of the evaluation process.
